The undersigned, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is: Pensacola SRO, Inc.

The address of the principal office of this corporation shall be 3 West Garden Street, Suite 339, Pensacola, Florida 32501, and the mailing address of the corporation shall be the same.

ARTICLE II

CORPORATE DURATION

The duration of the corporation is perpetual.

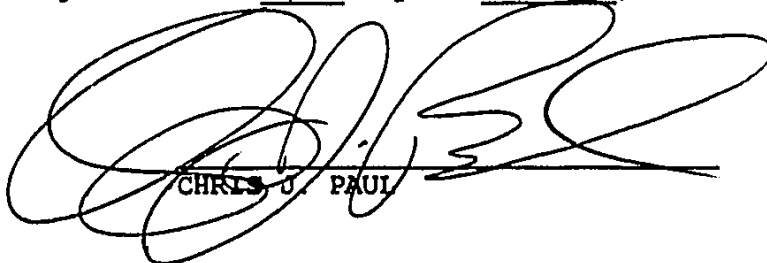
