The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

is Christopher M. Love, 3356 Bird Ave. #15, Miami FL 33133.

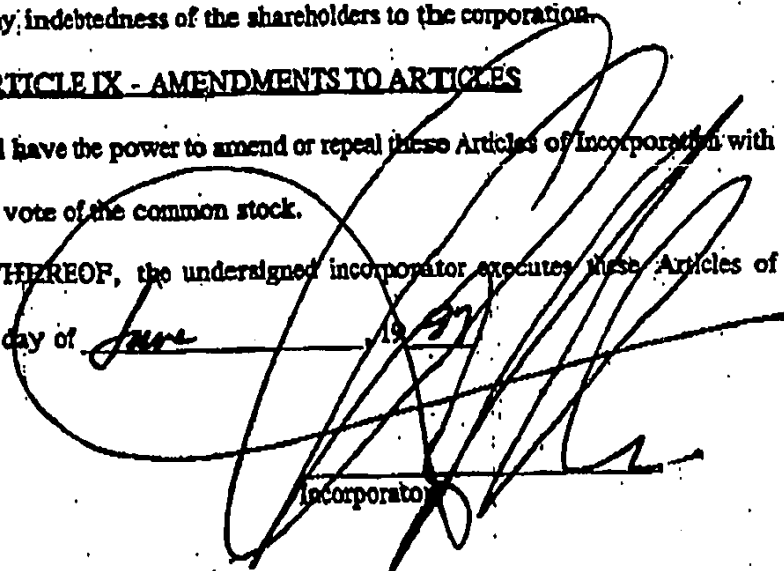
ARTICLE VIII - SHAREHOLDER PROPERTY
