

**NAME**



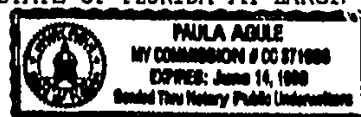
