ARTICLES OF INCORPORATION

OF

ACX COMPONENT XCHANGE CORPORATION

The undersigned, acting as incorporator of this corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME.

The name of this corporation is ACX COMPONENT XCHANGE CORPORATION.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation are 1933 West Copans Road, Pompano Beach, Florida 33064.

ARTICLE III. CAPITAL STOCK.

The number of shares of stock that this corporation is authorized to have outstanding at anyone time is 1,000 shares of common stock at \$10.00 par value per share.

ARTICLE VI. DURATION.

The corporation shall have a perpetual existence.

ARTICLE VII. PURPOSE.
