# ARTICLES OF INCORPORATION OF DATA LINK CONSULTING INC.

#### TO THE SECRETARY OF THE STATE OF FLORIDA

The undersigned persons, acting as incorporators of a corporation organized pursuant to the Florida Business Corporation Act as amended, hereby adopt the following Articles of Incorporation.
