**ARTICLES OF INCORPORATION
OF DATA LINK CONSULTING INC.**

TO THE SECRETARY OF THE STATE OF FLORIDA

The undersigned persons, acting as incorporators of a corporation organized pursuant to the Florida Business Corporation Act as amended, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME: The name of the corporation shall be known DATA LINK CONSULTING INC.

ARTICLE II

PERIOD OF DURATION: The period of duration of DATA LINK CONSULTING INC. shall be perpetual unless dissolved under the laws of the State of Florida or changed in accordance with these Articles and the corporation Bylaws.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of conducting proper aspects of business in a manner in which the corporation was organized for operation under the State of Florida as amended, with the principal purpose of engaging in the sale of Data processing equipment, software and network consulting services with principal interest in small to medium business.

ARTICLE IV

AGGREGATE SHARES: The aggregate number of shares which the corporation is authorized to issue is 1000, consisting of one class with no par value. The voting rights will be exercised in direct relation to the number of shares held by the single class established.



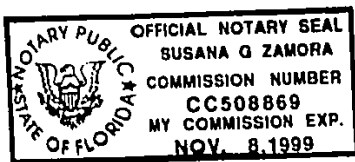


