# ARTICLES OF INCORPORATION

The undersigned subscribera, natural person competent to contract, hereby associate and together to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:

# ARTICLE I - NAME

The name of the corporation shall be:

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation, or the date of execution and acknowledgement of these Articles.

# ARTICLE III - PURPOSE
