ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Stage Investments, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 270 S.W. 31st Street Fort Lauderdale, Florida 33315

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
