ONE: The name of the corporation is INTERNATIONAL SINGLES EVENTS, INC.

TWO: The effective date of the corporation is June 23<sup>rd</sup>, 1997. The duration of the corporation shall be perpetual.

THREE: The general purpose or purposes for which this corporation is being formed are to include the transaction of any or all lawful business permitted under the laws of the STATE OF FLORIDA and the UNITED STATES OF AMERICA.
