I, the undersigned subscriber to these Articles of Incorporation, being a person competent to contract, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, Tiability, rights, privileges, and immunities of corporations for profit.

ARTICLE I - NAME
