ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is CELLULAR NECESSITIES,

INC., whose principal office or mailing address is 101 Butternut

Lane, Longwood, Florida 32779.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE
