ARTICLES OF INCORPORATION

OF

EXPRESS TARIFF ADVISORY GROUP, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I Name and Address

The name of the Corporation shall be EXPRESS TARIFF ADVISORY GROUP, INC. and its mailing address is 9269 Park Boulevard, Seminole, Florida 33777.

ARTICLE II Purpose and Powers

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.
