CERTIFICATE OF INCORPORATION
OF

I (WE) the undersigned, do hereby associate ourselves together and subscribe this certificate of incorporation for the purpose of forming, a corporation under the laws of the State Of Florida, and subject to the following.

Provisions:

*****ARTICLE ONE*****

The name of the corporation shall be :

AMERICAN BUILDERS INTERNATIONAL, INC.

*****ARTICLE TWO*****

The corporation may engage in any activity or business permitted under the laws of the United States Of America and of the State Of Florida.

*****ARTICLE THREE*****

The maximum number of shares of stock which the corporation shall have outstanding at any time, shall five hundred (500) shares of stock which shall be common stock of a par value of One (\$1.00) dollars per share, all or any part of the capital stock may be paid for either in lawful monies of the United States Of America, or in services, at a true value thereof.

*****ARTICLE FOUR*****

This corporation shall begin business with a minimum capital of the amount of five hundred (\$500.00) dollars..

*****ARTICLE FIVE*****

This corporation shall have perpetual existence.





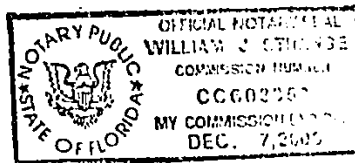
