With respect to the Articles of Dissolution, please find the completed Articles of Dissolution for Dynamic Imaging Corp. completed and signed by President Jeffrey Ingram. Such Dissolution was effective August 1, 2000. Please also find attached a check made payable to the Florida Department of State for filing fees in the amount of \$35.00. Please file this immediately.

Just as important is the letter from Lee Rivers discussing Dynamic Imaging Corp. of DELAWARE requesting to file as a foreign corporation doing business in Florida.
