**NAME OF CORPORATION**

The name of this corporation shall be UNITED FUND RAISERS OF AMERICA, INC.

**ARTICLE II**

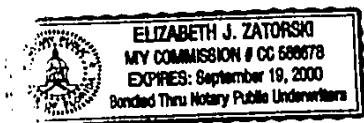

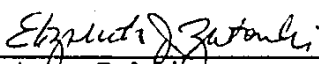
