The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the provisions of Chapter 607 Florida Statutes:

**ARTICLE I. NAME**

The name of this corporation is SERVIDEX, INC. (the "Corporation").

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 100 shares of Common Stock having a par value of \$0.01 per share.


**ARTICLE IV. - INITIAL REGISTERED


