The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE I

Name

The name of the Corporation shall be SEPTIC HELPER 2000 - SEPTIC TANK & DRAIN CLEANER, INC.

ARTICLE II

Principal Place of Business
