Articles of Incorporation for the purpose of forming a corporation under the

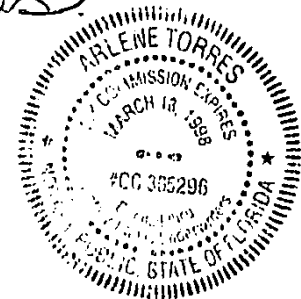
