ARTICLES OF INCORPORATION
OF
TIF INVESTMENTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE
NAME

The Corporate name is TIF Investments, Inc.

ARTICLE TWO

The duration of the Corporation is perpetual.

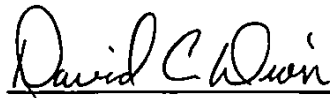

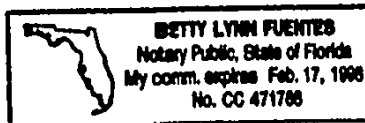

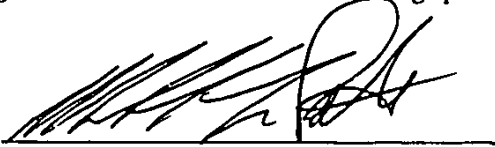
