**ARTICLES OF INCORPORATION OF WEB STRATEGIES, INC.**

The undersigned, acting as incorporator of WEB STRATEGIES, INC. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is: WEB STRATEGIES, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The principal office of the Corporation is: 1000 15th Street North, St. Petersburg, Florida 33705

**ARTICLE III. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

**ARTICLE IV. INITIAL REGISTERED AGENT AND STREET ADDRESS**

The street address of the initial registered agent of the corporation is: 1000 15th Street North, Saint Petersburg, Florida 33705, and the name of the corporation's initial registered agent at that address is Steve Fisher. Mailing address for the corporation is: Post Office Box 76383, Saint Petersburg, Florida 33734. I am hereby familiar with and accept the duties and responsibilities as registered agent for said corporation.

**ARTICLE V. INCORPORATOR**

The name and street address of the incorporator is: Steve Fisher 1000 15th Street North, Saint Petersburg, Florida 33705. The incorporator of the corporation assigns to this corporation his rights under Section 607.161, Florida Statutes, to constitute a corporation, and he assigns to those persons designated by the board of directors any rights he may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.

**ARTICLE VI. NO PRE-EMPTIVE RIGHTS**

No holder of shares of the common stock of the Corporation shall have any pre-emptive or preferential right of subscription to any shares of common stock of the corporation, whether now or hereafter authorized, issued or sold, nor any right of subscription to any thereof other than such, if any, as the Board of Directors in its discretion may from time to time determine and at such price as the Board of Directors may from time to time fix.

**ARTICLE VII. INITIAL BOARD OF DIRECTORS**

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided by the laws of the State of Florida, never be less than one. **ARTICLE VIII. AMENDMENTS**

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation. These Articles may be amended prior to the issuance of shares of the corporation by the unanimous approval or consent of the board of directors. Thereafter, every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a shareholders' meeting by holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.
