ARTICLES OF INCORPORATION OF WEB STRATEGIES, INC.

The undersigned, acting as incorporator of WEB STRATEGIES, INC. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
