ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is JOHNNY ON THE SPOT CLEANERS, INC.

Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

ARTICLE II. TERM OF EXISTENCE

The duration of the corporation is perpetual.

ARTICLE III. NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act or engaged in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV. CAPITAL STOCK

It is the intention of this corporation that the stock shall qualify as "Section 1244 Stock" as such term is defined in the Internal Revenue Code and the regulations issued thereunder.

ARTICLE V. ADDRESS

The street address of the principal office of the corporation and the mailing address of the corporation is 1753 N.E. 178TH STREET, NORTH MIAMI BEACH, FLORIDA 33162 and the name of the initial registered agent at such address is EVELYN MARTINEZ LEBRON.

ARTICLE VI. DIRECTORS

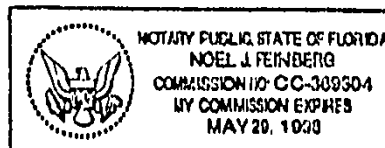
