The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and does form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Cigar Traders, Inc..

ARTICLE II

The location of its principal office in the State of Florida is 206 N.E. 1st Ave., Hallandale, Florida 33009, but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States or foreign countries as said corporation may from time to time determine.

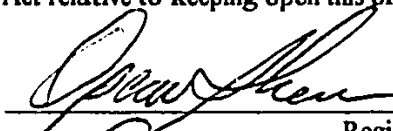
ARTICLE X

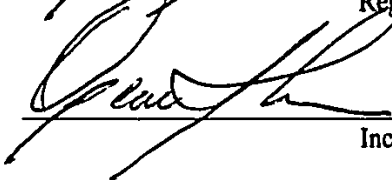
ARTICLE XI

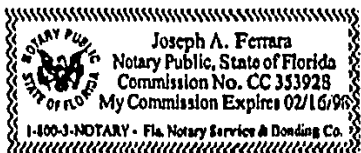
