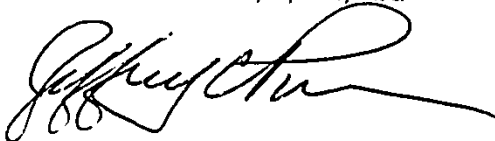

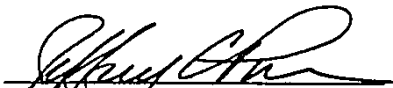
ARTICLE X

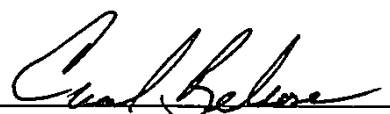

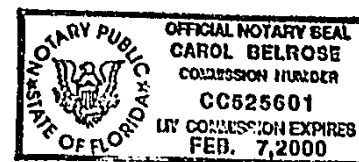
