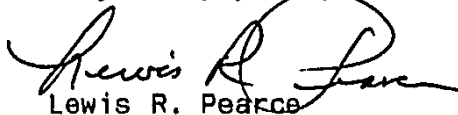

The name of this corporation is SAUNDRY ENTERPRISES, INC.

**Article II - Duration**

This corporation shall exist perpetually. The date of commencement of corporate existence shall be June 28, 1997.

The shareholders of this corporation shall have the exclusive authority to fix the compensation of directors of this corporation.

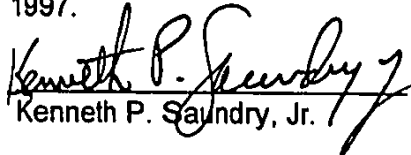
### **Article XI - Indemnification**

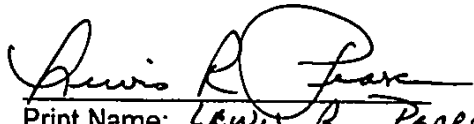

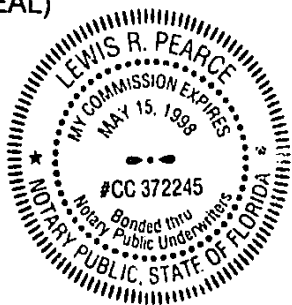

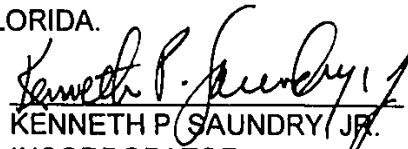
