ARTICLES OF INCORPORATION

ARTICLE I

Name of Corporation

The name of this corporation is: ALVA DISTRIBUTOR, INC.

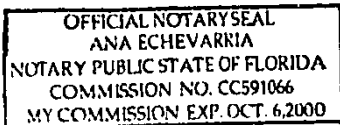
