The undersigned incorporator hereby forms a corporation under Chapter 607, Florida Statutes, as follows:

**Article I-Name**

The name of the corporation shall be Peninsula Property Services, Inc., and the principal office and the mailing address of the corporation shall be 4200 25th Avenue SW.

**Article II-Nature of Business**

The corporation is authorized to conduct any activities as are permitted under applicable Florida Statutes.

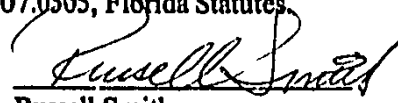
