ARTICLES OF INCORPORATION

OF

GWF, INC.

A Florida Corporation

ARTICLE I - NAME

The name of this corporation is: GWF, INC.

ARTICLE II - DURATION

These Articles of Incorporation shall become effective upon the date of their execution and acknowledgment, provided these Articles are filed by the Department of State within five (5) days of their signing and acknowledgment. If not, these Articles shall become effective upon the date they are filed by the Department of State.

ARTICLE III - GENERAL PURPOSES

The general purpose for which this corporation is initially organized is to engage in any or all lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV - SHARES

The maximum number of shares that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock (having a par value of \$1.00 per share), which shall have voting rights as follows: 1 share of voting Common Stock shall have voting rights; 999 shares of non-voting Common Stock shall have no voting rights.

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4118 Salina Lane, Ormond Beach, Florida 32174. The name of the initial Registered Agent of the corporation is Glenn R. Padgett.

ARTICLE VI - PRINCIPAL OFFICE


