The name of this corporation is G2C, INC.

The powers to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and shareholders.

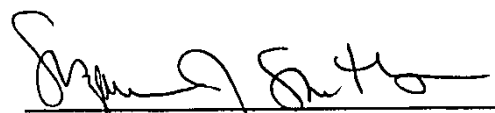

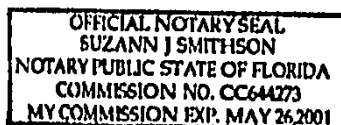
