**ARTICLE ONE**

The name of the corporation is ALTERNATIVE MEDICAL CLINICS, INC. The principal office of the corporation is 708 1st Avenue South, Tierra Verde, Florida 33715.

The period of its duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.




