ARTICLES OF INCORPORATION
OF
TIBURON ASSET MANAGEMENT, INC.

The undersigned, JON CHRISTIAN PETERSON, JR., being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be TIBURON ASSET MANAGEMENT, INC. and the business address and location of the Corporation shall be 1115 East Livingston Street, Orlando, Florida 32803.

ARTICLE II

CORPORATE DURATION

This Corporation shall commence to exist upon the filing of these Articles of Incorporation. The duration of the Corporation is perpetual.

act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the above-mentioned objects, purposes or authority.

CAPITAL STOCK
