THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person component to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is:

ARTICLE II

The general nature of the business to be transacted by this corporation is:

To engage in activities related with motor vehicle repairs, sales, and services.
