ARTICLE I - NAME

The name of this corporation is IRON HORSE PROPERTIES CORPORATION (the Corporation").

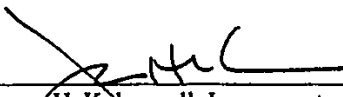

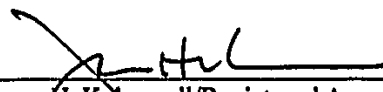
The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.
