**ARTICLES OF INCORPORATION
OF

The undersigned hereby subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the Florida General Corporation Act, Florida Statutes, Chapter 607.

ARTICLE I

NAME

The name of this corporation shall be DACRA WASHINGTON HOLDINGS, INC.

GENERAL NATURE OF BUSINESS AND POWERS

This corporation shall commence its existence on June 25, 1997 and shall have perpetual existence.
