THE UNDERSIGNED, acting as the sole incorporator of Skopos Enterprises, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

Article I

Name

The name of the corporation is Skopos Enterprises, Inc.

Article II

Effective Date

The effective date of the corporation shall be the date the Articles of Incorporation are filed.

Article III

Shares

The number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000), One Dollar (\$1.00) par value per share. In the event that stock other than common is issued, compliance with Florida Statutes, Section 607.0602 will be observed.

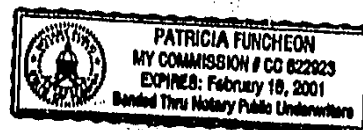

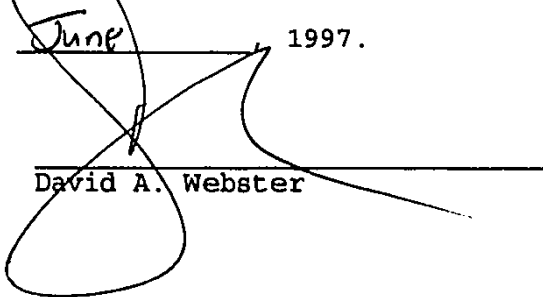
