

ARTICLE ONE

The name of the corporation is **BRADLEY AND BRADLEY AND ASSOCIATES, INC.** The principal address of the corporation is: 2331 S.W. 80 Terrace, Miramar, Florida 33025.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100)** of no par value.


ARTICLE FIVE


## ARTICLE EIGHT
