The undersigned incorporator to these ASAFT clest of Incorporation hereby forms a corporation under the laws of Athe State of Florida as follows:

ARTICLE I Name and Address

The name of this Corporation is: **ECOVENTURE WGV 13, INC.** The street and mailing address of the Corporation is 601 Bayshore Boulevard, Suite 960, Tampa, Florida 33606.

ARTICLE II Term of Existence

The Corporation shall have perpetual existence, commencing upon the date of filing of these Articles of Incorporation with the Florida Department of State.
