ARTICLES OF INCORPORATION SECRETARY OF STATE OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is: MOYNA, INC.
The principle address of the corporation is: 110 U.S. Hwy. 27, South Bay, FL 33493.

ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
