

PLAN OF MERGER adopted on December 23, 2005 by resolution of the Board of Directors of VIDAL PARTNERSHIP (FLORIDA), INC., a business corporation organized under the laws of the State of Florida, and adopted on December 23, 2005 by resolution of the Board of Directors of VIDAL PARTNERSHIP, INC., a business corporation organized under the laws of the State of New York. The names of the corporations plenning to merge are VIDAL PARTNERSHIP (FLORIDA), INC., a business corporation organized under the laws of the State of Florida, and VIDAL PARTNERSHIP, INC., a business corporation organized under the laws of the State of New York. The name of the surviving corporation into which VIDAL PARTNERSHIP (FLORIDA), INC. plans to merge is VIDAL PARTNERSHIP, INC.

- 1. VIDAL PARTNERSHIP (FLORIDA), INC. and VIDAL PARTNERSHIP, INC., shall, pursuant to the provisions of the Florida Business Corporation Act and the provisions of the laws of the jurisdiction of organization of VIDAL PARTNERSHIP, INC. be merged with and into a single corporation, to wit, VIDAL PARTNERSHIP, INC., which shall be the surviving corporation upon the effective date of the merger and which is sometimes hereinafter referred to as the "surviving corporation", and which shall continue to exist as said surviving corporation under its present name pursuant to the provisions of the laws of the jurisdiction of its organization. The separate existence of VIDAL PARTNERSHIP (FLORIDA), INC., which is sometimes hereinafter referred to as the "non-surviving corporation", shall cause at the effective time and date of the merger in accordance with the provisions of the Florida Business Corporation Act.
- 2. The certificate of incorporation of the surviving corporation at the effective time and date of the merger in the jurisdiction of its organization shall be the certificate of incorporation of said surviving corporation and said certificate of incorporation shall continue in full force and effect until amended and changed in the manner prescribed by the provisions of the laws of the jurisdiction of organization of the surviving corporation.
- 3. The bytaws of the surviving corporation at the effective time and date of the merger in the jurisdiction of its organization will be the bytaws of said surviving corporation and will continue in full force and effect until changed, attend, or amended as therein provided and in the manner prescribed by the provisions of the laws of the jurisdiction of its organization.
- 4. The directors and officers in office of the surviving corporation at the effective time and date of the merger in the jurisdiction of its organization shall be the members of the first Board of Directors and the first officers of the surviving corporation, all of whom shall hold their directorships and offices until the election and qualification of their respective successors or until their tenure is otherwise terminated in accordance with the bylaws of the surviving corporation.
- 5. Each issued share of the non-surviving corporation immediately prior to the effective time and date of the merger shall, at the effective time and date of the merger, be extinguished. The issued shares of the surviving corporation hall not be converted or exchanged in any manner, but each said share which is issued at the effective time and date of the merger shall continue to represent one issued share of the surviving corporation.
- 6. The Pian of Merger herein made and approved shall be submitted to the shareholders of the non-surviving corporation for their approval or rejection in the manner prescribed by the provisions of the Florida Business Corporation Act, and the merger of the nonricks: 281782v1

surviving corporation with and into the surviving corporation shall be authorized in the manner prescribed by the laws of the jurisdiction of organization of the surviving corporation.

- 7. In the event that the Plan of Merger shall have been approved by the shareholders entitled to vote of the non-surviving corporation in the manner prescribed by the provisions of the Florida Business Corporation Act, and in the event that the merger of the non-surviving corporation with and into the surviving corporation shall have been duty authorized in compliance with the laws of the jurisdiction of organization of the surviving corporation, the non-surviving corporation and the surviving corporation hereby stipulate that they will cause to be executed and filed and/or recorded any document or documents prescribed by the laws of the State of Florida and of the State of New York, and that they will cause to be performed all necessary acts therein and elsewhere to effectuate the merger.
- 8. The Board of Directors and the proper officers of the non-surviving corporation and of the surviving corporation, respectively, are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Pian of Merger or of the merger herein provided for.
