Under Section 607.0202 of the
Business Corporation Act
of the State of Florida

The undersigned, a natural person of the age of eighteen years or over, for the purpose of forming a corporation pursuant to the provisions of the Business Corporation Act of the State of Florida, does hereby certify as follows:

FIRST: The name of the Corporation (the "Corporation") is EMBASSY PAINTING COMPANY, INC.

SECOND: The Corporation is formed for the purpose of engaging in any lawful act or activity for which corporations may be organized under the Business Corporation Act of the State of Florida.

THIRD: The principal office and mailing address of the Corporation shall be: 10344 Panama Street, Cooper City, FL 33026.


