

ARTICLES OF DISSOLUTION OF HOME BANCGROUP, INC.

Home Bancgroup, Inc. (the "Corporation") does hereby set forth the following in connection with the dissolution of the Corporation pursuant to Sections 607.1403, et. al., of the Florida Business Corporation Act (the "Act"):

FIRST: The name of the corporation to be dissolved is Home Bancgroup, Inc.

SECOND: The document number of the corporation is P97000056579.
