**ARTICLES OF INCORPORATION
of

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation

Article One

Name

The name of the Corporation is Medical Support Services, Inc.

Article Two

Duration

The Corporation shall commence existence as of the date of filing of these articles. The term and existence shall be perpetual.

Article Three

Purpose

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

Article Four

Capital Stock

The aggregate number of shares which the corporation has the authority to issue is Ten Thousand (10,000) common shares, all of which shall be common shares with a par value of Fifty Cents (\$.50) per share.

Article Five

Preemptive Rights Granted

For each shareholder of any class of stock of this Corporation shall be entitled to full preemptive rights to purchase his prorata share of unissued or treasury shares of the Corporation of the same kind, class or series as that which he already holds, and securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares at a price at which is offered to others (without the issuance of fractional shares).

Article Six

Restriction of Transfer of Stock

Shares held by the initial shareholder may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholder(s) or to this Corporation. The price and terms at which such shares may be offered and resold shall be determined by an affirmative vote of 3/4 of the outstanding shares of this corporation.
