ARTICLE I - NAME

The name of this Corporation is PIOVERA CORP.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

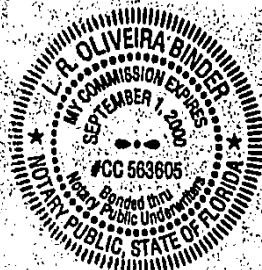
