**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
JULY PROJECT III CORP.**

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of July Project III Corp. (the "Corporation"), a corporation organized and existing under and by virtue of the Florida Business Corporation Act, bearing Document # P97000056725, is hereby amended so that Article I reads, in its entirety, as follows:

**ARTICLE I
CORPORATE NAME**

The name of this Corporation shall be GLOBALGROUP INVESTMENT HOLDINGS, INC.
