Attached please find copy of a letter we received from you with cheque #3273 written back in May 22nd, and sent in on July 13th with a letter stating the fact that I had inadvertently misplaced the envelope under some other documents, and while I thought I had mailed it to you, it was actually buried in my desk.

I spoke to Mr. Andy Dunlap on October 14th and he suggested to write another letter explaining what had happened and that maybe you would be able to wave the penalty. As I told him, these is only the beginning of our second year in business, as you know it is very hard for a new business with no working capital (like us) to manage without full time staff which we cannot yet afford. We are overloaded with administrative paperwork that unfortunately gets backed up and yet we have to give priority to servicing our clients who are the ones who make it possible for us to be in business in the first place. It becomes a vicious circle.

Since we started a little over a year ago, both my husband and myself have worked overtime in our company, we have been able to live (very modestly) out of our efforts, and have been able to provide work through subcontracting, another 40 people. Our resources are at the present very limited but we have good potential. We are starting to make a name for "Transwords-Net, Inc.", which has taken tremendous effort and hard work and we feel proud of our accomplishment. A penalty of \$400.00 for us right now is extremely high and it would have a negative impact. I plead to you not to penalize us so harshly, and accept our \$150.00 filing fee. You can be sure next filing will be timely.

I appreciate your understanding and help in this matter.
