

I, the undersigned incorporator, for the purpose of forming a corporation under the provisions of Chapter 607, Florida Statutes, Florida Business Corporation Act effective July 1, 1990, do hereby make, execute and adopt the following articles of Incorporation to-wit:

**ARTICLE I      NAME**

The name assumed by this corporation and by which it shall be known in law EFFECTIVE    June 26, 1997, is
