ARTICLES OF INCORPORATION

OF

PLAYGIRL FASHIONS, INC.

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

1. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be PLAYGIRL FASHIONS, INC. The principal place of business of this corporation shall be 2040 Collier Avenue, Fort Myers, FL 33901.

2. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

3. CAPITAL STOCK
