ARTICLES OF INCORPORATION

We, the undersigned, natural persons competent to contract, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter, and we do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation, and to that end we do by these Articles set forth:

ARTICLE I

The name of this corporation shall be Fassbender Enterprises, Inc..

ARTICLE II DURATION

The duration of the corporation shall be perpetual unless sooner dissolved according to law.

ARTICLE III PURPOSE

The general nature of the business, objects and purposes proposed to be carried on and transacted, are to do any and all lawful business for which corporations may be incorporated under the laws of the State of Florida including but not limited to the following:

- (a) Operation of a Restaurant d/b/a the Wine Cellar in Ft. Lauderdale, Florida;

of the shares of capital stock, or any bonds, securities, or evidence of indebtedness created by any other state or government, and while the owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote thereon;

- (d) The purposes specified herein shall be construed both as powers and purposes and shall in no wise be limited to or restricted by reference to, or inference from, the terms of any other clause in this or any other Article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers shall not be construed to limit or restrict in any manner the meaning of the general terms of or the general powers of the corporation under the laws of the State of Florida; nor shall the expression of one thing be deemed to exclude another, although it be of like nature, not expressed;

- (b) Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro-rate share thereof (as nearly as may be done without the issuance of fraction shares) at the price at which it is offered to others.

ARTICLE Y CAPITAL INVESTMENT

The amount of capital which this corporation will begin business will not be less than one thousand (\$1,000.00) dollars.

ARTICLE V PRINCIPAL OFFICE

ARTICLE IX ADDITIONAL POWERS
