
Dear Mr. Scott:

Please accept the above captioned corporation's checks in the amount of \$300 to pay the 2003 Uniform Business Report fee and the 2004 For Profit Corporation Annual Report fee. My client has told me the 2003 Uniform Business Report was never received --- apparently due to the change in address.

When the State of Florida changed its reporting procedures for the 2004 Annual Reports we discovered online Worthington Ventures, Inc.'s 2003 Uniform Business Report fee had not been paid. The corporate officers have told us they did not receive the 2003 Uniform Business Report. Apparently due to the change in the mailing address, the 2003 Report was never received.
