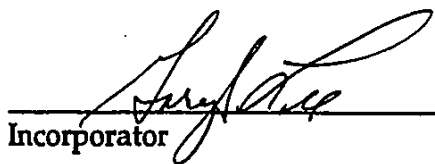
Articles of Incorporation
